PARISH NURSE JULY

Stay safe on the 4th of July. Our Health News for July:

 July is skin care during Sunshine month. You also need sunscreen in shaded areas

You will get sunburned faster if you are in the water.

Sun exposure is considered the single greatest risk for developing skin cancer.

The sun's strongest rays occur between 10am and 4pm.

Certain over-the-counter and prescription drugs can elevate your sensitivity to the sun rays...

- The sun's rays contain 2 types of ultraviolet let lights- Ultraviolet A and Ultraviolet B. ULA causes tanning, aging skin, and wrinkles. UVB causes sunburn. Use water resistant or waterproof sunscreen which protects against both UVA and UVB sun's rays and has an SPF of at least 15; apply every 2 hours after swimming or sweating to prevent sunburn.
- Every time a person gets a skin tan or burn, DNA (deoxyribonucleic acid) builds up in the deeper skin layers. If one has 5 or more burns in a life time, the chance of getting skin cancer doubles. Wear sunglasses, a brimmed hat, protective clothes, and use sunscreen SPF of at least 15.
- 4. If you have children, keep them in the shade on sunny days. Infants under 6 months should not be exposed to the sun. Seek emergency care if a child of any age has a sunburn with fever, blistering, severe pain or listlessness.
- Risk factors for overexposure to damaging UV rays: 0-2 low, 3-5 moderate, 6-8 high, 8-10 very high, 11 extremely high. Hope you are having a wonderful summer while protecting your skin!

Blood Pressure Checks will be as needed.

The Meeting was called to order at 10:53 AM by President Steve Neumann. The minutes from the May 21, 2023 meeting were reviewed. Carol moved for approval. Motion carried.

Treasurer's Report: Nedra Neumann reviewed the Treasurer's report. It was requested that Nedra bring more detailed information from the April to May differences. She also pointed out that the Quick books renewal plus upgrades of the program jumped the cost from \$549.00 to \$1,111.94.

Committee Reports: Worship & Music. Carol announced that the cost of the latest hymnals cost \$24.00 each. If we decide to acquire them, we will search other congregations, and ask for donations.

Tim Vogel, property chairman, reported on status of the shed. He recommended that we discontinue use of the dumpster service. He reported that all the weeded areas have been sprayed with weed killer. He also announced that the Church cleaning contract is coming due.

Old Business: Pastor Bryan needs a minimum of 20hours/week and benefits. He felt that serving two churches would help. Our committee is going to meet with the United Church on 6/11/23 to discuss this.

Carol introduced the proposed fee schedule for church use. We will review at home and discuss at the next meeting.

New Business: We have \$959.00 that needs to be put in some account. We will discuss next month.

Ed Mallett thanked us for use of the church for Tuba Bach programs. He would like to keep the wall up year round, because of the damage that occurs when it is taken down, put up or stored. He is willing to work on modify the wall meet our concerns if possible. Steve Neumann will review this with him.

Dave Scott advises that we discontinue the Sunday morning Radio Broadcasts. This will save \$250.00 monthly. Carol moved that we do this, seconded by Phyllis. Motion carried

Phyllis asked that we ask the congregation to help in cleaning the fans we use in the summer by taking them home to clean. we use these all summer. Each fan taken should be returned within a week. Permission granted.

Meeting closed at 12:00.

VISION COMMITTEE

Report of the Vision Committee: Included in this issue of the Messenger is a one-page updated summary of Immanuel's five alternative futures. This summary was also presented at the June 18 congregational conversation. At its June 5 meeting, the Vision Committee discussed the following items in addition to Immanuel's alternative futures:

- 1. First meeting of the United/Immanuel Joint Study Team: Lee Wolken reported that the United Church team members were positive about expanding shared ministries on an informal basis for now. United is calling a full-time pastor so discussion about a more formal partnership may be delayed until that decision has been made. However, the joint team will continue to meet to explore all options for partnership.
- 2. Call of a part-time pastor: David Scott reported on issues that have arisen in that the expectations of the pastor we planned to call have changed. David S. will continue to facilitate the process with the hope that a path forward will become possible.
- 3. We will restart the Ministry Leadership Network to put more focus on ministries beyond Sunday morning.

UPDATED DISCUSSION ON IMMANUEL'S ALTERNATIVE FUTURES

ALTERNATIVE FUTURE ONE: MEMBER-LED, PASTOR SUPPORTED CHURCH. (small but mighty): Future now being enacted pending dialogue with United Church. Major opportunities and challenges:

Call of part-time pastor
Building on current excellent Sunday morning worship services, restart fellowship hour programming, strengthen congregational care ministries, and develop "Beyond Sunday Morning Ministries" including ministry events and expanded community outreach.
Incorporate shared ministries with United Church and other regional churches.
Explore rental of spaces in church building, especially lower (terrace level) floor (secure realtor advice?
Information gathering: cost of elevator, kitchen upgrade, and road/sidewalk to terrace level (Steve and Nedra N,).
Identify additional possibilities to develop Immanuel as a community resource and cultural center (city county, FSU, ??)
Plan and implement celebration of Immanuel's 80 th anniversary in 2025 and the 150 th anniversary of the first Lutheran church in the Big Rapids area in 2024.
Other major Future One opportunities and challenges?
ALTERNATIVE FUTURE TWO: PARTNERSHIP WITH UNITED CHURCH (work of United/ Immanuel Joint Study Team to explore all options:
United/Immanuel Joint Study Team develops informal ministry partnership and expands shared United/Immanuel ministries.
United/Immanuel formal covenant agreement—shared pastor, separate identities, separate or shared facilities.
Merger
(If and when an ongoing partnership with United Church develops, most aspects of Immanuel being a member-led, pastor supported church will likely need to continue.)
ALTERNATIVE FUTURE THREE: PARTNERSHIP WITH ST. PAUL'S IN REED CITY OR OTHER CHURCH. (No current exploration; keep options open).
ALTERNATIVE FUTURE FOUR: SELL FULLER STREET ASSETS AND MOVE TO SMALLER
LOCATION. Any interest in exploring this option? Would involve selling all or most of Immanuel's as-
sets; a small margin after sale seems possible. Key questions: How many current members would be inter
ested in participating in a move to a new location? Is such a move feasible and/or desirable? Next step—further study of this alternative future? (also awaits clarification by Schuberg family of deed restrictions).

ALTERNATIVE FUTURE FIVE: DISBAND AS A CONGREGATION. Formally disband, help members find new church homes, sell Fuller Avenue assets to pay off mortgage and contribute margin (if any) to another church, the synod, and/or local charity. If there is no margin, remaining debt is assumed by the Mission Investment Fund of the ELCA. No planning is necessary; this is the future we are striving to prevent. (This alternative future also waits clarification by the Schuberg family of deed restrictions.) Recognizing our emerging aging, membership, financial, and worship attendance issues, the year 2023 is the time period to identify and execute one or more of the above alternatives so that Alternative Future Five can be avoided.
